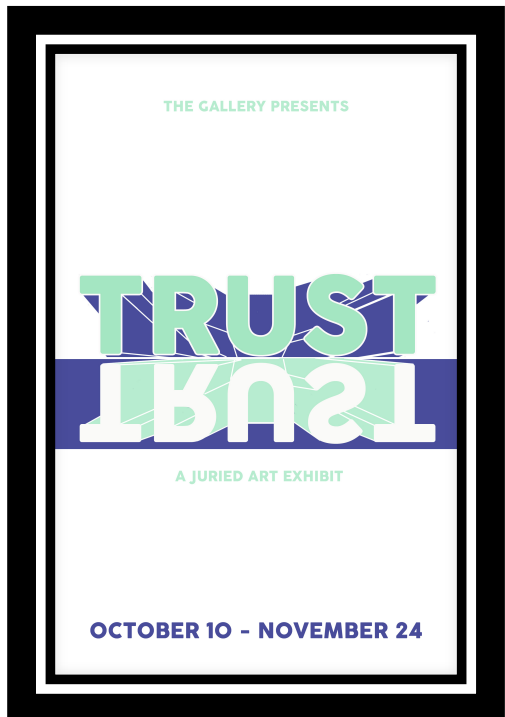


# TRUST

## Eligibility:

- Open to all ages, 13 years or younger require parent/guardian's permission.
- Only original fine art accepted: paintings, photography, mixed media, and graphics. ***Due to limited space in the gallery, no 3-dimensional work will be accepted.***
- Size limitations for all works should be no larger than 48"x 48" including frame.
- All works accepted for the show must remain in the show until the show ends.

- Each artist may submit **up to three works**.
